

AMENDATORY AGREEMENT

This Amendatory Agreement is made on this 25th day of February, 2019.

BETWEEN

JOHNSON CONTROLS HITACHI AIRCONDITIONING INDIA LIMITED (formerly known as HITACHI HOME AND LIFE SOLUTIONS (INDIA) LIMITED) having CIN - L29300GJ1984PLC007470, a public limited company duly incorporated under the provisions of the Companies Act 1956, having its Registered Office at 9th Floor, Abhijeet, Mithakali Six Roads, Ahmedabad – 380 006, and Head Office and Works at Village Karan Nagar, Tal. Kadi - 382715, District Mehsana, Gujarat (hereinafter referred to as 'Company' or 'JCH-IN', which expression shall unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors, permitted assigns and attorneys) of the **ONE PART**.

AND

INDUSTRIAL TRAINING INSTITUTE (ITI) Kadi, a Vocational Training Institute, permitted under the aegis of Director General of Employment and Training, Ministry of Labour and Employment, Government of India, having its training Institute at Kadi, Kadi Nandasan Road near Adarsh Nivasi School, Kadi, District- Mehsana.

The Government Industrial Training Institute (ITI) Kadi is under the aegis of Labour and Employment Department, Government of Gujarat. Director, Employment & Training, represents all the ITI is authorized representative of the Institute of the OTHER PART, called hereinafter as 'INSTITUTE'

JCH-IN and INSTITUTE may be referred to individually as a "Party" and jointly as "Parties".

WHEREAS:

1. JCH-IN had entered into Memorandum of Understanding with Institute for providing benefits of Vocational Training, Skill upgradation and Skill development trainings to students. (hereinafter referred to as the "Said Memorandum of Understanding").
2. The said Memorandum of Understanding is valid upto 31st March, 2019.
3. In accordance with the terms of the said Agreement, the Parties are now desirous to modify, amend and supplement the provisions of the said Agreement and or its Annexures to the extent recorded in this Amendatory Agreement.

NOW THEREFORE IT IS HEREBY AGREED BY AND AMONGST THE PARTIES HERETO AS FOLLOWS:

1. That this Amendatory Agreement shall be effective from 1st April, 2019 ("Effective Date").
2. That as per clause 3 of said Memorandum of Understanding, the term of this MOU is extended for a further period of 1 year from 1st April, 2019 to 31st March, 2020.
3. That Expense detail of said Memorandum of Understanding, shall be amended and read as under:

That the Parties hereby confirm and acknowledge that this Amendatory Agreement shall form a part and parcel of the said Memorandum of Understanding from the Effective Date of this Amendatory Agreement and that the terms of this Amendatory Agreement shall be read in conjunction with and not in derogation to the Memorandum of Understanding.
